In the year 1964, two friends from middle class families Mr. Naginbhai Shah and Shri Niranjanaben Soni, started this FUND with an amount of ₹ 10/- from their own pockets and self-confidence and selfless desire to serve the poor patients.

Since then for the last 48 years, the Trust is in service of the poor patients of Sheth V. S. Hospital, Victoria Jubilee Hospital and Jivraj Mehta Hospital, etc. with gifts of medicines, fruits, ear-phones, artificial limbs, etc. The volunteers of the Trust visits daily the General Wards of Sheth V. S. Hospital and renders the service of medical aid, etc. to the patients. At present the monthly expenses of the Trust are about ₹ 8,00,000/-towards the help rendered to patients only.

FOR THE LAST 49 YEARS THERE HAS NOT BEEN A SINGLE PAISE SPENT ON ADMINISTRATIVE EXPENSES LIKE CONVEYANCE, ETC., BUT NOW, TRUST IS SPENDING 3 TO 4 % IN ADMINISTRATIVE EXPENSE, SALARY, ETC.

During these 49 years the Trust has collected over ₹ 12 Crore and 31 Lac and spent the entire amount on helping the patients as per the following details:

- (a) More than 5,68,000 poor patients have taken medicines.
- (b) Provided 810 Artificial Limbs.
- (c) Provided 380 Ear-phones.
