
Message

Dear Shri Naginbhai


I am in receipt of yearly report 2016-17 for the Trust named as "Dardionu Rahat Fund" which has rendered its services to the poor patients for 53 years.



It always gives us great pleasure to affirm that DARDIONU RAHAT FUND, 102, Kashiparekh Complex, has been established since 1964 in Ahmedabad. Led by Shri Naginbhai M'.Shah, the Fund has been providing free medicines, drugs, surgical items, LV. fluids and other help in the form of MRI and CT Scans, Gamma bottles (costing as much as Rs. 1000 each), injections for skin patients costing Rs. 32,000 each etc., to needy patients in the general wards of V. S. Hospital, about 50 to 60% of whom are below the poverty line.

The volunteers of DARDIONU RAHAT FUND visit our wards daily bed to bed, without fixing any budgeted amount in advance, and identify poor patients of any cost, creed and religion and provide them medical aid as necessary.

Though now in his eighties, Naginbhai is fired by his enthusiasm to provide succour and the Fund spends approximately Rs. 50,000 per day on an average on needy patients over and above.

As per our knowledge this year DARDIONU RAHAT FUND have spent nearly Rs. 1 Crore after poor & needy patients of V. S. Hospital.
